


Reclassification of Use Classes



Reclassification of Use Classes

The Government has made radical changes to the Town and Country Planning Use Classes Order 1987 (as amended).

The Town and Country Planning (Use Classes) (Amendment) (England) Regulations 2020, which come into force on 1 September 2020:

- create new use classes, namely Class E ("commercial, business and services" uses); Class F1 ("learning and non-residential institutions" uses); and Class F2 ("local community" uses); and
- reclassify a number of uses.

The new classes – notably Class E – are broad use classes encompassing a number of previous use classes. Movements between uses within the same use class do not require planning permission because such change does not constitute "development".

The 2020 Regulations apply only to England.

Transitional provisions

These reforms to the use classes will not apply to the General Permitted Development Order 2015 between 1 September 2020 and 31 July 2021. During this "material period", any references to the uses or use classes specified in the GPDO or article 4 directions are to be read as references to the uses classes which were specified in the Use Classes Order on 31 August 2020 (i.e. before the above changes take place).

Applications for prior approvals in the "material period" under existing PD Rights will be assessed against the current Use Classes

Order

Applications for planning permission, permission in principle or reserved matters, submitted before 1 September 2020 which refer to uses or use classes in the current Use Classes Order, must be determined by reference to those current use classes. Once implemented, however, in the absence of controls in the permission such uses may fall within the new classes for the purposes of the Use Classes Order.

Next steps

We understand that the Government intends to introduce new, revised permitted development rights at the end of the "material period" so we can expect changes to the GPDO before the end of next summer.

The Government also intends to update the planning practice guidance before 1 September 2020.

The table below summarises the reclassification of the Use Classes Order which shall come into effect on 1 September 2020.

¹ Please note that, amongst other things, for the purposes of the General Permitted Development Order 2015, the previous use classes will apply during the material period (i.e. from 1 September 2020 – 31 July 2021). It is expected that the Government shall introduce new permitted development rights to come into effect at the end of the "material period" in Summer 2021.
